Dear Brothers and sisters in Christ,

After Governor Evers most recent "Safer at Home" mandate, with a desire to keep the 4th Commandment by obeying civil authorities, and a desire to keep the 5th Commandment by not hurting or harming our neighbors in body, the Board of Elders of Redeemer has decided to continue drive-up communion until all mandates are lifted and freedom of movement is again restored. Communion is not necessary for our salvation. It is important for the forgiveness of sins, and for the strengthening of our faith, and the encouragement that we receive by communing with others. However, we do not want to cause anyone undo risk or fear by burdening their consciences. We are taking precautions to keep people safe.

We are now also offering another worship option for those who do not have internet access or a DVD player. An FM transmitter has been installed at church, so that the audio part of the service will be available over your FM radio, as long as you are in the church parking lot to be in range of the transmitter. We will play the audio of the service during the times of drive-up communion (**Sunday 9:30 -11:30 am, and Wednesday 4:30 – 6:30 pm**). You can tune your radio to 88.3 FM to receive the service. The Green Bay Police Department has stated publicly that they will not be enforcing the "Stay at Home" order. So we are still in compliance with the governor's mandate, as long as fewer than 10 people are in the church at one time. Sitting in your car in the parking lot does not make you part of that gathering. And a reminder, If you would like to take communion, but do not want to get out of your vehicle, I will bring it out to you. In these challenging days, with many churches having only an online presence for their Services instead of meeting in person, it is important that every member realize that while Redeemer's on-site worship services may have been cancelled, the church's ongoing ministry and mission continues.

The faithful, weekly giving of the Redeemer members makes possible the continued fulfillment of the ongoing ministry and mission of our Lord Jesus Christ.

Here are some ways that you can remain faithful in your giving responsibility and continue to fund the continued ministry and mission of Redeemer:

- Give to Redeemer by using the VANCO (Simply Giving) personal banking online bill pay service. This is very convenient as many people pay their bills online these days. Simply fill out the information noted in the attachment, and send back to Cathy at Redeemer and it will be set up. (redeemergreenbay@gmail.com) This method does not cost the church or the giver any additional fee.
- Lastly, if you are already set up for PayPal, you can go to the Redeemer web-site and scroll down to the very bottom, Click on the yellow "DONATE" box and you will be able to make either or one-time or a monthly donation.

EXECUTIVE COMMITTEE MTG

Board of Elders: The board of elders met on Monday March 2, 2020.

In the book Pastors and Elders, we studied challenges we face in a self-absorbed culture and an example of how to deal with some situations.

We reviewed a letter and a questionnaire prepared by Pastor Pett that will be mailed to members who have not worshiped in over 2 years. Any questionnaires returned to us hopefully will give us some feedback on why a member has been absent for so long.

We discussed the possibility of combining the two Sunday worship services into one service which would include the praise team. The discussion began regarding how this would make sense considering attendance. However, we then discussed the health of our pastor and how his current condition contributes to fatigue and that too would be a reason for having one service. We want to discuss this with the executive committee and discuss again at the congregation meeting on March 22.

A motion was made by Jayne Busarow and seconded by Jim Wirch to proceed with one 9:15 am service on Sunday's beginning at a TBD date. Motion passed unanimously

Communion will be served at all Sunday services in April & May.

Board of Mission and Ministry Report: No Report

Board of Property Report:

New Glass railing for Balcony –Keith Larson will be calling and working with Tom Kloen to get a design together and figure out when we can get this completed. It will probably take about 1 week to complete and we may be down media temporarily during installation.

Moving Pastor's office to School. We have a tentative estimate of \$7,000 to build a new office space for pastor in school attached to the existing office. This would provide better communication between Secretary and Pastor. Also protecting Pastor in the event of issues arising during a counselling session.

New Chairs and Tables are here and we sorted the old chairs to see which ones need to be scrapped or able to sell. Keith Larsen has 2 parties that are interested in buying our old chairs.

Storage of the new round tables will be in one of the open classrooms until the stage area is redeveloped for 2 stories of storage. We have a March 21st as a scheduled work date to start cleaning the stage. Question was asked by a member of the congregation if this project needs to be voted on by the members to see if we do it or not?

We met with Trio Heating and Cooling to get a quote for new church AC system. Final quote came back at \$37,500. Pastor had the contract signed and was working with Lynn to get a check to them to start the process of installation. A couple of parts need to be custom built and when they are completed the installation of the systems will take place.

Church basement upgrade is not quite finished and Keith will be working on it to get wrapped up.

Now with better weather we will work on installing the new car port lights, which we already have. And we have a new idea for backlighting the front wall cross. This will be a cove molding to be installed on the side of the cross reflecting the LED lights to the back. This should create the same look without taking the cross down.

February 2020 offerings were \$25,782.00, compared with \$19,803.00 in February 2019. Total February income was \$28,254.00 including offerings, other and Thrivent Choice. Total expenses paid in February were \$29,464.00. The balance for the Board of Property's account is \$13,200 as of February 29th.

Looking to create an Endowment funds with special memorials that were given to Redeemer. More discussing at the March 22nd Congregation Meeting.

New Business:

Time & Talent sheets have been turned in and have been compiled will be distributed to the appropriate committees. Discussed Project list for current/upcoming memorial funds.

Lorin Sternberg attended a 2-day Safety & Security Symposium. Lots of good speakers and topics on active shooters, medical emergencies, first aid and fire safety. Will begin to put plans into place. More to come. Upcoming Meetings:
